**ORDER DENYING CASINO GAMING EMPLOYEE LICENSE RENEWAL
APPLICATION**

On November 15, 2017, Edward Pirie filed a Casino Gaming Employee License Renewal Application (“Application”) with the Ohio Casino Control Commission (“Commission”). Thereafter, the Commission conducted Pirie’s suitability investigation to determine his eligibility for such a license.

During the investigation, the Commission discovered sufficient derogatory information to warrant issuance of a Notice of Opportunity for Hearing (“Notice”), dated June 7, 2018. Pirie received the Notice, sent via certified mail, on June 9, 2018.

Pursuant to R.C. 119.07 and 3772.04, Pirie had the right to a hearing if requested within 30 days of the Notice’s mailing. Pirie so requested, and the Commission scheduled a hearing for July 12, 2018; and upon its own motion, the Commission continued the hearing until August 30, 2018. Pirie and his counsel did not appear at the hearing but did submit a Memorandum in Support of Renewal of Gaming Employee License in lieu of personal appearance. The Commission held the hearing as scheduled before Hearing Examiner Margaret A. Brewer (“Examiner”).

After presentation and submission of the evidence at the hearing, the Examiner closed the hearing record. The Examiner prepared a Report and Recommendation (“R&R”), which she submitted on October 10, 2018. Therein, the Examiner recommended that the Commission deny Pirie’s Application.

On October 11, 2018, the Commission sent Pirie, via certified mail, a copy of the R&R, which he received on October 13, 2018. Therefore, Pirie had until November 13, 2018, to file objections. *See* R.C. 3772.04(A)(2). Pirie did not do so.

In accordance with R.C. 119.07 and 3772.04, the matter was submitted to the Commission on December 12, 2018, for final adjudication.

WHEREFORE, in consideration of the foregoing and upon a quorum and majority vote of the members, the Commission **ADOPTS** the Examiner’s R&R without modification.

WHEREFORE, in consideration of the foregoing and upon a quorum and majority vote of the members, the Commission **ORDERS** as follows:

- 1) Pirie's Application is **DENIED**.
- 2) Pirie is **PROHIBITED** from working or otherwise serving in any capacity that requires a license under R.C. Chapter 3772.
- 3) Pirie is **PROHIBITED** from reapplying for licensure under R.C. Chapter 3772 for three years from the date the Order is served upon his, absent a waiver granted by the Commission commensurate with Ohio Adm.Code 3772-1-04.
- 4) A certified copy of the Order shall be served upon Pirie, via certified mail, return receipt requested, and his counsel of record, if any, via ordinary mail.

IT IS SO ORDERED.

NOTICE OF APPEAL RIGHTS

The Party is hereby notified that pursuant to R.C. 119.12, the Commission Order may be appealed by filing a Notice of Appeal with the Commission setting forth the Order that the Party is appealing from and stating that the Commission's Order is not supported by reliable, probative, and substantial evidence and is not in accordance with law. The Notice of Appeal may also include, but is not required to include, the specific grounds for the appeal. The Notice of Appeal must also be filed with the Franklin County Court of Common Pleas in accordance with R.C. 119.12. In filing the Notice of Appeal with the Commission or Court, the filing may be either the original Notice of Appeal or a copy thereof. The Notice of Appeal must be filed within 15 days after the date of mailing of the Commission Order.
