RESOLUTION 2020-30

**CONSIDERATION OF 39 SKILL-BASED AMUSEMENT MACHINE
LICENSE APPLICATIONS**

WHEREAS, Article XV, Section 6(C)(4) of the Ohio Constitution created the Ohio Casino Control Commission (“Commission”);

WHEREAS, R.C. 3772.03(K) grants the Commission jurisdiction over all persons conducting or participating in the conduct of skill-based amusement machine operations authorized by R.C. Chapters 3772 and 2915;

WHEREAS, Ohio Adm.Code 3772-50-03 provides, generally, that all skill-based amusement machine operators, vendors, locations and key employees must be licensed by the Commission;

WHEREAS, Ohio Adm.Code 3772-50-04 through 3772-50-08 describe the criteria the Commission shall use when evaluating an applicant’s suitability for licensure;

WHEREAS, the 39 entities and individuals listed on Exhibit A have applied for a skill-based amusement machine-related license in compliance with the requirements under Ohio Adm.Code 3772-50-03 through 3772-50-08;

WHEREAS, the Commission’s Division of Skill Games (“Division”) reviewed the applications and other materials and information and conducted a thorough review of each application for compliance with the requirements of R.C. Chapters 3772 and 2915 and Ohio Adm.Code 3772-50;

WHEREAS, the Division has not uncovered any derogatory information that would make any of the entities or individuals listed in Exhibit A not suitable to be granted a license; and

WHEREAS, the Commission reviewed all submitted materials and information and considered the matter at its public meeting on August 19, 2020.

NOW, THEREFORE, BE IT RESOLVED by the Commission that the type-B skill-based amusement machine operator, type-C skill-based amusement machine operators, type-C skill-based amusement machine locations, skill-based amusement machine vendor and skill-based amusement machine key employees are **SUITABLE** and **ELIGIBLE** for licensure.

BE IT FURTHER RESOLVED that the Applicants are hereby **LICENSED** for a period not to exceed three years, subject to continued compliance with R.C. Chapters 3772 and 2915 and the rules adopted thereunder and the following conditions:

- (A) As a condition precedent to licensure, all Applicants listed on Exhibit A shall pay all fees required by the Commission, including a nonrefundable license fee, as required by Ohio Adm.Code 3772-50 within the timeframe required by H.B. 197 of the 133rd General Assembly; and
- (B) An Applicant's failure to comply with condition (A) of this Resolution within the specified time period will result in that Applicant's approval being null and void and the application shall be closed, unless the time period is otherwise extended by the Executive Director.

BE IT FURTHER RESOLVED, that Resolution 2020-30 does not in any way affect, negate, or otherwise absolve the applicants from their obligations to comply with R.C. Chapters 3772 and 2915 and the rules adopted thereunder and all other conditions imposed by the Commission.

BE IT FURTHER RESOLVED, that Resolution 2020-30 does not restrict or limit the Commission's future exercise of authority and discretion with respect to imposing additional conditions or taking further action upon the applicants under R.C. Chapters 3772 and 2915 and the rules adopted thereunder.
